Privacy Policy for Prolight Diagnostics AB (publ)

Prolight Diagnostics AB (publ), reg.no. 556570-9499, with address Gasverksgatan 3A, 222 29 Lund, Sweden ("**Prolight Diagnostics**" or "**we**"/"**us**") is committed to processing your personal data in an integrity-secure manner with a good level of protection and in accordance with applicable data protection legislation. Therefore, we have established this Privacy Policy, which clarifies how we process personal data about you as a representative of a company that is a customer or supplier or potential customer or supplier of Prolight Diagnostics, and you who visit our website www.prolightdx.com, and you who apply for employment with us. This Privacy Policy also describes how Prolight Diagnostics processes personal data about you if you are a shareholder or representative of a shareholder or a holder or representative of a holder of other financial instruments that can be exchanged for, converted into or give the right to acquire shares in Prolight Diagnostics ("**Shareholder**").

What personal data do we process?

The personal data processed by Prolight Diagnostics is described below.

Customers, suppliers and cooperation partners

Prolight Diagnostics collects and stores the following information about you that Prolight Diagnostics needs in order to contact you and fulfil Prolight Diagnostics' obligations to you as a customer, supplier or cooperation partner:

- Personal and contact information, such as name, social security number, address, telephone number and email address.
- Data that you provide to Prolight Diagnostics by email, through our social media or other communication channels.
- · Customer survey data.
- Customer, supplier and/or cooperation agreements.
- Payment information, such as bank details, account numbers and, where applicable, IBAN, SWIFT, etc.
- Where applicable, information on dietary preferences, possible allergies and/or disabilities (e.g. on the occasion of corporate events or meetings).

Company representatives of, e.g. customers, suppliers and cooperation partners

Prolight Diagnostics collects and stores the following information about you that Prolight Diagnostics needs in order to contact you as a representative of a company or organisation:

- Personal and contact information, such as name, address, telephone number, email address, title, position and employer.
- Data that you, as a company representative, provide to Prolight Diagnostics by email, through our social media or other communication channels.
- Where applicable, information on dietary preferences, possible allergies and/or disabilities (e.g. on the occasion of corporate events or meetings).

Potential customers, suppliers and cooperation partners and company representatives of potential customers, suppliers and cooperation partners

Prolight Diagnostics may collect and store the following information about you as a potential customer, supplier or cooperation partner of Prolight Diagnostics or as a company representative of a company that is a potential customer, supplier or cooperation partner of Prolight Diagnostics. Prolight Diagnostics needs this information to contact you in your capacity as a (potential) customer, supplier or cooperation partner of Prolight Diagnostics or representative of a (potential) customer, supplier or cooperation partner of Prolight Diagnostics and to fulfil Prolight Diagnostics' obligations towards you or Prolight Diagnostics for which you are a representative:

 Personal and contact information, such as name, address, telephone number, email address, title, position and employer.

Visitors to Prolight Diagnostics' website

When you visit Prolight Diagnostics' website, we collect the following information about you, which Prolight Diagnostics needs in order to improve, streamline, simplify and develop our website, as well as to accommodate those who subscribe to our press releases:

 Technical data, such as IP address, MAC address, URL, unique device ID, network and device performance, browser, language and identification settings, geographical location, operating system, and other data from cookies or similar mechanisms (device information).

Recruitment (job seekers at Prolight Diagnostics)

Prolight Diagnostics collects the following information about you, which we need to recruit the right people for positions in Prolight Diagnostics:

- Personal and contact information, such as name, address, telephone number, email address, title, position and employer.
- Information in your cover letter and CV.
- If applicable, picture.
- Other information that you provide to us in connection with recruitment.

Shareholders

Prolight Diagnostics collects the following information about you as a Shareholder to fulfil Prolight Diagnostics' obligations and to ensure Shareholders' rights:

- Personal and contact information, such as social security number, name, address, telephone number, e-mail address, and position.
- Holding of shares or other financial instruments.
- Financial information, such as information on voting rights at general meetings, shareholding and ownership rights.
- Any information on proxies representing Shareholders.
- Any information on trustees, pledges and pledgees, and other entries in the central securities depository register.
- Any other information provided by you or the organisation you represent.

Other information

Regarding customers, suppliers and cooperation partners as well as company representatives and customers, suppliers and cooperation partners, as well as potential customers, your personal data is generally collected from the company or organisation you represent, but where applicable, directly from you, e.g. via email, our social media or other communication channels or in the context of corporate events or meetings. Prolight Diagnostics may also receive personal data about you from other companies within the Group of which Prolight Diagnostics is part or from Prolight Diagnostics' other cooperation partners. Furthermore, Prolight Diagnostics may use external information services to supplement existing information, e.g., with position and contact information, if necessary.

Regarding visitors to Prolight Diagnostics' website and job seekers at Prolight Diagnostics, personal data about you may be transferred to us directly from you or from the staffing, recruitment or hiring company through which you seek employment.

How do we use your personal data?

We process your personal data primarily to fulfil and administer our legal obligations and requirements from authorities, follow and fulfil agreements entered into, and enable marketing.

We may use your personal data for the following purposes and on the following legal bases:

Customers, suppliers and cooperation partners (including their company representatives)

Recruitment (job seekers at Prolight Diagnostics)

The processing is necessary for Prolight Diagnostics' legitimate interest in hiring the right staff and ensuring that competent persons work for Prolight Diagnostics (legitimate interests).

Shareholders

Purpose	Legal basis
To fulfil Prolight Diagnostics' obligations to you as a Shareholder according to Prolight Diagnostics' Articles of Association.	The processing is necessary to fulfil Prolight Diagnostics' contractual obligations towards you according to the Articles of Association (performance of contract).

Who do we share your personal data with?

Prolight Diagnostics does not disclose personal data to third parties except when this is required to fulfil a legal obligation or to fulfil Prolight Diagnostics' commitments to you, customers and/or cooperation partners. The table below sets out situations where your personal data may be disclosed to third parties.

Third party	Reason to disclose personal data to third party

Suppliers and cooperation partners	Prolight Diagnostics may disclose your personal data to various suppliers and/or cooperation partners if they need your personal data to fulfil their tasks for Prolight Diagnostics.
Governmental authorities	Personal data may be disclosed to governmental authorities when required to fulfil legal obligations.
Disposal	If Prolight Diagnostics intends to transfer all or part of Prolight Diagnostics' business, personal data may be disclosed to a potential buyer.
General public	The Prolight Diagnostics share register is public and available at Prolight Diagnostics for anyone to consult. The information contained in the share register is, therefore, provided upon request.
	The minutes and voting list from the general meeting may be disclosed to Shareholders present at the meeting, the Swedish Companies Registration Office, auditors, and others to whom Prolight Diagnostics has a legal obligation to provide the minutes or otherwise deems it appropriate to disclose them.

Information on, inter alia, major Shareholders may be disclosed to authorities, advisors and the public in connection with preparing prospectuses, information memoranda and financial reports.

Your personal data will not be sold to third parties for advertising purposes.

Transfer of personal data to third countries

Prolight Diagnostics may transfer your personal data to countries outside the European Union (EU) or the European Economic Area (EEA). If your personal data is transferred to any country outside of the EU/EEA, Prolight Diagnostics will take the necessary steps to ensure that such data is transferred lawfully and that your personal data is processed in a secure manner and with a level of protection equivalent to that within the EU/EEA, for example by entering into the European Commission's standard contractual clauses with the recipient. Regarding the personal data contained and processed on social media sites such as Facebook, Twitter and LinkedIn, we refer users to the policies of each service for information on how they process personal data. According to Prolight Diagnostics, the purpose of the processing is to enable representatives of existing customers, potential customers and cooperation partners of Prolight Diagnostics to interact and liaise with Prolight Diagnostics via social media. This is to contribute to a good relationship with customers and cooperation partners. The processing is necessary for Prolight Diagnostics' legitimate interest in marketing its brand and products to existing and potential customers as well as to cooperation partners (legitimate interests).

How long is your personal data stored?

Your personal data is kept for as long as there is a need to keep the data to fulfil the purposes for which the data was collected in accordance with this Privacy Policy. Your data will then be deleted.

Certain personal data will, in order to comply with relevant accounting legislation, be stored for seven years, starting from the end of the calendar year in which the financial year to which the information relates ended.

Contact information of company representatives are stored for as long as Prolight Diagnostics deems it necessary to maintain the relationship with the company/organisation. Deletion shall take place when Prolight Diagnostics becomes aware that the data is no longer adequate or relevant for the purpose or at the request of the contact persons.

How is your personal data protected?

We have procedures and working methods to ensure that your personal data is handled in a secure manner so that you can feel safe when you submit your personal data to us. Only persons who need the personal data to fulfil their work tasks and Prolight Diagnostics' commitments shall have access to personal data. Our security systems are designed with your privacy in mind, protecting

your personal data against unauthorised access, alteration, and deletion. We will not disclose your data to anyone else, except as expressly stated in this Privacy Policy.

Your rights

Right to correction and deletion

You may have the right to request that your personal data be corrected or deleted. If Prolight Diagnostics does not have a legal basis to continue processing the personal data, it shall be deleted. You can request a correction when the personal data that Prolight Diagnostics processes about you is inaccurate, incomplete, or outdated.

Right to object and request restriction

You may have the right to object to how Prolight Diagnostics processes your personal data. In some cases, you have the right to request that the processing of your personal data be restricted so that Prolight Diagnostics may only process the personal data under certain conditions (this refers to handling other than storage).

Right to an extract from the register

You have the right to request extracts from Prolight Diagnostics and our registers/systems in which personal data about you are processed, and in such extracts be informed about which personal data about you that Prolight Diagnostics processes.

Right to data portability

Where personal data is processed with your consent or with the support of an agreement with you, you have the right to obtain your personal data in a machine-readable format and transfer the data to another data controller.

The right to submit a complaint to a supervisory authority

You have the right to submit a complaint about Prolight Diagnostics' processing of your personal data to the Swedish Authority for Privacy Protection, Box 8114, SE-104 20 Stockholm, Sweden.

You may also have the right to withdraw consent for any process that requires consent.

What happens if you do not provide your personal data to Prolight Diagnostics?

If you do not provide your personal data to Prolight Diagnostics, we will not be able to fulfil our legal or contractual obligations towards you. For Shareholders, this means you will not be able to exercise your rights as a Shareholder, including attending and voting at general meetings.

Changes

Prolight Diagnostics has the right to change the Privacy Policy at any time. Upon changes to this Privacy Policy, Prolight Diagnostics will publish the amended Privacy Policy on www.prolightdx.com with information about when the changes will take effect. Prolight Diagnostics may also inform customers and cooperation partners in an appropriate manner.

Cookies

Prolight Diagnostics uses techniques similar to cookies to provide certain functions on the www.prolightdx.com website, improve the website and deliver a better and more personal service. The information is stored as a file containing encrypted login-data.

Personal data manager and our assistants

Prolight Diagnostics is a personal data controller, which means that we are responsible for how your personal data is processed and that your rights are safeguarded, in accordance with applicable legislation.

Prolight Diagnostics has personal data assistant agreements with suppliers and cooperation partners, thereby ensuring that personal data is processed in accordance with this policy.

The central securities depository is the data controller for the processing of personal data in the central securities depository register.
